



BACKGROUND INFORMATION

The **European meetings of people experiencing poverty** were developed as a response to the agreed EU objective; to develop the active engagement of people with direct experience of poverty and social exclusion. This objective was developed in the context of the Open Method of Coordination on Social Protection and Social Inclusion (Social OMC) and re-stated in the context of the Europe 2020 strategy.

The general objectives of the meetings are:

- To foster commitment to developing the participation of people experiencing poverty and social exclusion at local, national and European levels.
- To reinforce the visibility of the fight against poverty and social exclusion in Europe and to recognise the expertise that people experiencing poverty have in assisting to address that reality.
- To recognise and reinforce the courage needed for people experiencing poverty to engage in the struggle to improve their realities and the reality of their communities.
- To make visible the links between the different levels - local, national and European - and the need for coherence between the different levels.

Theme and Content for the 11th Meeting: The theme for the 11th European meeting is "Homelessness and Housing Rights in the Context of the Crisis". The ambition is an exchange of views and experiences on how to ensure that people experiencing poverty can have access to adequate, affordable and energy efficient housing and accommodation. To make steps towards that ambition this year's meeting will be focused on three key questions:

- In relation to homelessness and housing rights what are the key differences that can be seen in 2012 as compared to 2008?
- From the experience of the delegates and the preparation work for the meeting what are the 'good and bad practices' in relation to addressing homelessness and housing rights that have been identified?
- How best to design policies to address homelessness and housing that are adapted to the different needs and realities of different individuals and communities and can ensure equality in access to homeless services and housing rights?

The delegates will bring their own experience and the results of their preparation work to address these three questions. During the meeting itself these questions will be addressed in three methods:

- 1) Creative presentations from the delegations of people experiencing poverty
- 2) Workshops where the delegates will exchange on these questions
- 3) Dialogue meetings where the outcomes of the workshops are discussed with people who shape and seek to influence policies and programmes on homelessness and housing rights as well as stakeholders working with homeless people or on housing rights issues.

Participants:

- Delegations to the meeting are primarily people with a direct experience of poverty and social exclusion (including people with direct experience of homelessness) who have begun to engage in a collective way to address the causes and effects of poverty and exclusion.
- Representatives of National Governments and EU institutions, Social Partners, NGOs and other relevant actors will be invited to participate.
